Crew Certification For Off Shore Vessels (Not Beach Launch)

The requirements for crew certification are listed in "The Jersey Commercial Vessels Code of Practice" In addition the Boats and Surf-Riding (Control) (Jersey) Regulations 1969 require all passenger carrying vessels operating in Jersey waters to have crew who the Harbour Master deems competent to act in that capacity to that end the Harbour Master requires that all charter boat (other than beach launch craft) skippers must attend the Harbour Office where they will be asked questions on local waters and local emergency procedures prior to being issued with a Jersey Boat Masters licence. Beach Launch Vessels

As with off shore charter vessels beach launch vessels must be compliant with the Jersey Code of Practice for Small Commercial Vessels, beach launch vessels requirements are covered under Annex 4 article 2 of the code.

Beach launch vessels are restricted to operation within one nautical mile from the shore within the bay of operation for skippered vessels and 1000m for self-drive vessels.

Manning For Beach Launch Vessels

The person in charge of a skippered vessel must as a minimum holds an RYA Power Boat Level 2 Certificate or equivalent depending on the activity taking place and an appropriate first aid certificate.

Self drive vessels must be monitored by a guard boat which must be manned by a person knowledgeable in the activities taking place and must as a minimum hold an RYA Power Boat Level 2 Certificate or equivalent depending on the activity taking place and an appropriate first aid certificate.

All commercial marine beach operations must be under the control of a person holding a nationally recognised qualification for the activity concerned, that person must be able to assess the ability of all those wishing to undertake a proposed activity to ensure that they are physically and mentally capable to safely do so.
