Pilotage

Pilotage is undertaken by Jersey Harbours and charges are detailed in the Commercial Tariffs published on portsofjersey.je, unless otherwise stated.

Pilotage is compulsory for all vessels **35 metres and over** in length, or if carrying **13 or more passengers**.

Berths

The use of berth or anchorage will be determined by the size of the vessel, height of tide, weather and sea conditions and is subject to change.
