# DECLARATION OF ELIGIBILITY

To register a British Ship under Part 3 of the Shipping (Jersey) Law 2002 (excluding Fishing Vessels)

Part 3 of the register is for merchant and pleasure vessels

\* For Part 3 registration, the property in a ship is divided into 64 shares

\* A share can be jointly owned by no more than 5 people

- \* to the best of my / our knowledge and belief, a majority interest in the ship is owned by persons qualified to be owners of British ships, and the ship is otherwise entitled to be registered under part 3 of the Law.
