# Marina Tariffs 2025

Whether you are a local boat owner, visitor to the Island or simply passing through, Jersey Marinas offers over 1,000 berths across its three award-winning marinas – St Helier Marina, Elizabeth Marina and La Collette Marina.

Jersey Marinas holds the prestigious '5 Gold Anchors' status, an internationally recognised symbol of quality awarded by The Yacht Harbour Association, recognising the quality and level of facilities and services provided to boat owners and providing a trustworthy measure of excellence.

Located on the New North Quay, adjacent to St Helier Marina, the Marine Leisure Centre is staffed by a knowledgeable, experienced and friendly team, many of whom are multi-lingual.

The centre is open all year and the team can provide a multitude of information and advice, ranging from advising on the services and facilities offered by the marinas, to helping visitors make the most of their stay in Jersey.

As well as the day-to-day management of all marinas and outlying harbours, the Marine Leisure Centre staff are also responsible for allocating marina berths and issuing long-term and monthly berthing contracts.

# Jersey Marinas 2025 terms and conditions for a berth or mooring

Agreements for individual berths/moorings in Jersey Marinas and Outlying Harbours are issued to a Permitted User (referred to as 'the User'). In accepting an Agreement for a berth/mooring position allocated by Jersey Marinas, the User accepts the following conditions:

1. The User agrees that the berth/mooring allocated is suitable for the vessel and accepts that it is moored at the Owner's/User's risk and not to hold Jersey Marinas responsible for any loss or damage howsoever caused;
  2. The User agrees when deciding to use harbour buoys, moorings and pontoons that they do so at their own risk;
  3. To comply with all directions of the Harbour Master or his representative, and in particular, to the manner and position in which the vessel is moored;
  4. That the berth/mooring may only be used by the vessel, which is subject of this allocation: no other vessel may be moored unless having received prior permission from the Harbour Master or his representative;
  5. That the berth/mooring will not be left vacant for a period exceeding one calendar year. Only occupancy by the vessel that is subject of this allocation is valid;
  6. The user agrees that Jersey Marinas, at its sole discretion and without compensation of fees, may use the berth for mooring of other vessels when not in use by the User's vessel, provided that Jersey Marinas shall use its best endeavours to ensure the berth, or a suitable alternative, is available for the User upon the vessel's return;
  7. To provide and maintain in safe working order all ropes and mooring chains, apart from the harbour's ground chains and mooring buoys;
    - a. Exceptions: St Catherine's, St Aubin's Outer and Belcroute moorings where the User is to provide, fit and maintain in good working order all dead men, ground chains, fittings, ropes and buoys.
  8. To accept the right of the Harbour Master or his representative whenever necessary in their opinion for the safety of the vessel, or other vessels/property nearby, to board, enter, move, moor or carry out emergency work on the vessel as is deemed necessary. The User shall pay the costs of any such work;
  9. The User shall not cause any nuisance, hazard or danger to other users of berths/moorings, members of the public or other persons operating on Ports of Jersey property;
  10. To secure the vessel and its content from theft and to comply with all fire prevention recommendations for the size and type of vessel as may be issued from time to time by Jersey Marinas and/or States Fire and Rescue Service;
  11. To maintain the vessel in a seaworthy condition and, if necessary, allow safety inspections by the Enforcement Manager of Ports of Jersey, with the recommended safety equipment consistent with the size and use of the vessel to, at least, the recommended RNLI 'Safety Guidelines for Recreational Users';
  12. To maintain third party risk to the minimum of £2million, and be able to produce evidence of insurance on request;
  13. To observe the Harbours (Jersey) Regulations 1962 as amended, the 'International Regulations for the Prevention of Collision at Sea 1972' and the Water Pollution (Jersey) Law 2000, Harbours (Inshore Safety) (Jersey) Regulations 2012 and other maritime or relevant Health & Safety regulations enacted from time to time;
  14. To ensure that any works or activities being undertaken, by a private individual, on the vessel or berth/mooring have been suitably assessed and that appropriate systems are in place to remove any risk of damage or harm to neighbouring vessels or persons. Where these risks have not been assessed and reduced so far as reasonably practicable, the work or activity must not take place;
  15. The User shall not cause or permit any alterations, modification or damage to Ports of Jersey owned equipment ie pontoons, harbour ground chains or mooring buoys, without prior permission from Ports of Jersey. In the absence of prior permission, Ports of Jersey may seek to recover costs to repair or replace damaged equipment;
  16. To pay all fees in connection with the berth / mooring on demand and notify Jersey Marinas of any change of contact details within seven days;
17. The fees applicable shall be those stated in the Marinas Tariffs (published at least annually and available on [www.jerseymarinas.je](http://www.jerseymarinas.je)) applying to the relevant period;
  18. At the request of the Harbour Master, to relocate in order to facilitate reorganisation, redevelopment, dredging or similar works undertaken;
  19. The berth/mooring is not transferable;
  20. The Ports of Jersey Terms of Credit shall apply, as from time to time amended;
  21. That a breach by the User of any of these Terms and Conditions, will constitute grounds for the Harbour Master to terminate without notice, the berth/mooring allocation and remove the vessel and mooring equipment at the expense of the User. The User may appeal, provided such an appeal is made within one month of notice termination;

Subject to the above, the Agreement may be cancelled by either party on giving one month's written notice. 'Annual contracts' are issued for a minimum period of six months. After the initial six months, the Agreement may be cancelled by either party on giving one month's 'written notice.

In other event should the User comply with the conditions of the above, the Agreement will automatically be renewed for a further calendar year subject to the payment of the appropriate fees and compliance with the prevailing Conditions of the Agreement.
  22. Jersey Marinas reserves the right to alter, suspend, cancel or otherwise vary these Terms and Conditions at any time. The current version of the Terms and Conditions shall be those that are available on the website: [www.ports.je](http://www.ports.je);
  23. For the avoidance of doubt, these Terms and Conditions supersede any previous Terms and Conditions and in the event of conflict between the provisions of these Terms and Conditions and contents of any other agreement entered into by or on behalf of Jersey Marinas, the provisions of these Terms and Conditions shall prevail.

## Ports of Jersey Terms of Credit from 1 January 2025

1. Invoices must be settled within a period of 30 days following the date of the invoice. Where a discount is applied, POJ reserve the right to rescind the discount if the invoice is not settled within a period of 30 days. The invoice must be paid in full and any incorrect charge or other error must be notified to: The Credit Controller, Finance Department, Ports of Jersey, St Peter JEL IBY Telephone: +44 (0) 1534 446389 Email: [enquiries@ports.je](mailto:enquiries@ports.je) Where any discrepancies are verified, these will be dealt with by the Finance Department by issuing the relevant invoice or credit note, as appropriate.
2. Settlement of invoices may be made by
  - Direct debit
  - Cheques - made payable to 'Ports of Jersey' and forwarded to the Credit Controller
  - Credit card - payment can be made over the telephone to the Finance Department
  - BACS transfer - bank details may be obtained from the Credit Controller. All charges relating to BACS transfers must be borne by the payer.
3. GST at the appropriate rate will be applied where applicable
4. Where an invoice remains unpaid beyond the period of credit granted, Ports of Jersey reserves the right to charge interest at a rate of 0.75% a month on the charges outstanding for late payments, with a minimum charge of £5.00.
5. Ports of Jersey will make an administration charge of £25.00 for each occurrence of the following events:
  - Cheques that are returned unpaid by the bank marked 'refer to drawer'
  - Direct debit payments that are refused by the paying bank owing to insufficient funds
6. If accounts are not fully paid within the prescribed period, Ports of Jersey reserves the right to revert to cash payments without further notice and/ or seek recovery of the outstanding amount through recourse to the relevant courts.
7. When any monthly credit facilities have been withdrawn, they may only be reinstated upon receipt of a deposit equivalent to the highest monthly account during the preceding twelve month period or other sum as may be determined by Ports of Jersey.
8. If there has been no activity on credit account for a continuous period of twelve months, the account will lapse and a fresh application will have to be made if it is decided to reactivate the account by the company concerned.
9. Ports of Jersey reserves the right to alter, suspend, cancel or otherwise vary these conditions at any time. The current version of the Terms and Conditions shall be those that are available on the website : [www.ports.je](http://www.ports.je)
10. For the avoidance of doubt, these Terms of Credit and in the event of conflict between the provisions of these Terms of Credit and contents of any other agreement entered into by or behalf of Ports of Jersey, the provisions of these Terms of Credit shall prevail.
